# NCC BCxA Board Member Tracey Jumper (Cornerstone Group Commissioning) Honored as New Face of Engineering 2011

They are the best of the best — the next generation of engineers whose innovation, leadership skills, and commitment to excellence are helping to better our world and inspire young people to consider a career in engineering. Among them is our NCC BCA board member Tracey Nawrocki Jumper. Jumper, who works with Cornerstone Group Commissioning, Ltd., Wilkes-Barre, PA was recently named one of only 14 individuals (age 30 and younger) from across the country who are being honored as the New Faces of Engineering Class of 2011 by the National Engineers Week Foundation, which is a coalition of engineering societies, major corporations and government agencies. Jumper is an architectural engineer and commissioning specialist. She was nominated by the American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE) for her work in commissioning, specifically for reducing energy use and costs while increasing patient comfort in healthcare buildings. Jumper is vice president and research promotion chair of the Anthracite Chapter of ASHRAE and currently the youngest member on the board of directors of the National Capital Chapter of the Building Commissioning Association.

# **Commissioning of the Shirlington Hilton Garden Inn**

Arlington, VA Reported By Mike Johnston (*BRINJAC*)

Brinjac provided LEED commissioning services (Basic and Enhanced) for a new 142-bed, 110,000 SF hotel. The project achieved LEED Silver accreditation. Design review services were performed on the DD, 65% CD and Bid Document submissions. The HVAC, lighting control and domestic hot water system were included. A Commissioning Plan was developed and presented at the Pre-Commissioning Meeting that was attended by the design team and the Contractors. During construction, the mechanical installation was periodically checked for compliance with LEED requirements. Performance Verification was conducted in both the heating and cooling seasons.

As part of the Enhanced Commissioning Services, a near-end-of-warranty site visit was made to check on the HVAC systems to assure that previously observed problems had been corrected. In addition, a Re-Commissioning Manual was prepared for the Owner to guide them in the process of keeping the systems maintained and performing properly.

An interesting feature of the HVAC systems is the use of Mitsubishi Citi-Multi Units to heat and cool the guest rooms. A single outdoor unit serves up to 16 indoor units (1 per room), simultaneously providing heating and cooling to the individual rooms based on the requirements of the guest.

# **Definition - ASHRAE Guideline 0, The Commissioning Process**

During the Pre-Design Phase, a Commissioning Team is formed to oversee, implement, and accomplish the Commissioning Process activities detailed in this guideline. Responsibility for leadership of the Commissioning Team should be defined and assigned at the beginning of the Pre-Design Phase. The term used for the person with overall responsibility for the Commissioning Process is "Commissioning Authority." The Commissioning Team members must be available for meetings, have the qualifications to contribute to the development of the Owner's Project Requirements, and have the authority to make decisions binding on the firms/constituencies they represent. Lines of authority and lines of communication in determining Commissioning Team members responsibilities shall be documented. The Commissioning Team composition must be based upon the scope of the Commissioning Process services established for the project.

### **Definition - ASHRAE Green Guide**

There are several schools of thought about what the CA should focus on during a design review. Two of them are presented below;

- 1. The first is to look only for commission-ability of the systems; that is, to only identify design elements that prevent functional testing, and similar "show stoppers". One example would be inaccessible battery posts in a UPS system, preventing thermographic scanning for termination hot spots. Design reviews that only assess commission-ability provide valuable information and address how a system would be tested to verify commissioned system performance.
- 2. The second type of commissioning is more comprehensive, beginning prior to design; it combines peer review to assess the design, a constructability review to minimize potential change orders, a quality control review that identifies possibly confusing or conflicting information in the contract documents, a value engineering review that does not compromise the serviceability or performance of a facility, and possible alternatives the design team should consider beyond commission-ability. This form of commissioning is generally considered to provide the greatest benefit, albeit at the greatest first cost.

### **Ecobuild America Conference**

The Ecobuild America Conference was held from December 6 through December 10, 2010 at the Washington Convention Center in Washington, DC. For several thousand attendees, the event offered educational sessions in sustainable design strategies, materials, case studies and much more. Representing the National Capital Chapter of the Building Commissioning Association, Tony DiLeonardo, a board member of the NCC, was invited as a moderator for one of the sessions: "How to perform Cost-Effective Building Tune-Ups".



**Ecobuild America Conference** 

This session included views, case studies and thoughts on building tune-ups from the retro-commissioning and continuous commissioning process, led by two experts on the subject. Both speakers discussed the steps involved in the processes, focusing on the investigation and persistence phases of these commissioning processes. The speakers also utilized the BCA's Best Practices for Existing Buildings Commissioning in educating the attendees. The presentations invoked some great questions from the attendees--and discussion which took the 90 minute session well into overtime.

Based on attendee feedback, the event proved to be worthwhile for increasing interest in both the Building Commissioning Association and Building Commissioning itself.
